

SERV. Terms and Conditions

These Terms of Use constitute a legally binding agreement made between you, whether personally or on behalf of an entity (“you”) and SERV. For Technical Consultation LLC (“we,” “us” or “our”), concerning your access to and use of the serv.jo website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”).
